-<u>Presentation</u> – Malahide Water & Wastewater Rate Study presented by Daryl Abbs of Watson & Associates

Mr. Abbs provided an overview of his presentation regarding the Malahide Water and Wastewater rate study.

Mayor Giguère advised Council prior to opening the floor for questions that there would be a report later in the agenda recommending Council formally adopt Watson's study and presentation as well as to consider the reports and By-laws for water and sewer rates.

Councillor Leitch inquired what development charges could be recovered with Bill 23 coming into effect. Mr, Abbs noted that there would be 15-20% reduction of what you could collect prior to making the questions.

Deputy Mayor Widner inquired about requirements for reserves. Mr. Abbs noted that there is no minimum balance but by 2025 it will be required to have a full financial strategy of how assets will be replaced. It is always a good idea to save to ensure you have a full cost recovery in place.

Councillor Glinski inquired about the liability that was referred to earlier in the presentation. Mr. Abbs clarified that if there is a problem with a water system for instance that the Council is financially liable and needs to be accounted for when looking at funding capital plans Manager of Water/Wastewater Gustavson expanded on this notion of liability to Council regarding the water/wastewater system.

Presentation – Catfish Creek Conservation Authority – Ice Breaking Services

Mr. Underhill of Catfish Creek Conservation Authority (CCCA) provided an overview of their correspondence submitted in regards to ice breaking services.

Deputy Mayor Widner inquired about an earlier report where the dragline wasn't supported. Mr. Underhill clarified that the use of any piece of equipment can't be guaranteed with the environmental impacts of the last flood but that CCCA prefers a dragline. Deputy Mayor Widner followed up inquiring about the effectiveness of a dragline

and its location. Mr. Dragunas of CCCA explained the draglines placement and effectiveness.

Mayor Giguère clarified statements between the current correspondence and previous reports. If CCCA thinks it's the best, can you explain what this machine doesn't do as you state as no machine is perfect. The downfalls aren't many as its been down there for many years but one would be that it can't be moved easily. Mayor Giguère followed up with the idea that if no machine is perfect that one year of data with unique patterns isn't enough information.

Councillor Cerna inquired if lake level is a factor. Mr. Dragunas stated CCCA didn't have current lake level information.

Councillor Lewis inquired if any clearing had been done at the north end of the break wall opening to lower this for an access point and would this help mitigate water. Mr. Dragunas said it was to be cleared out for vegetation purposes but would likely be helpful given previous examples.

Mayor Giguère inquired if the work for that spillway has been completed. Mr. Dragunas stated that CCCA made a recommendation for vegetation to be cleared out.

Councillor Wilson inquired what are the Municipal responsibilities for harbor upkeep as having a dragline there would indirectly do this when clearing ice. Mr. Dragunas can't vouch for that. CAO Betteridge sought clarification from CCCA as to Councillor Wilson's inquiry about municipal responsibilities and the conservation authority responsibilities. Mr. Dragunas noted neither have responsibilities and that it's the Government of Canada's.

Mayor Giguère thanked both Mr. Underhill and Mr. Dragunas for their presentation and they retired from the meeting.

Being a By-law to provide for a drainage works on the W. McIntyre Drain in the Township of Malahide, in the County of Elgin

WHEREAS the requisite number of owners have petitioned the Council of the Township of Malahide in the County of Elgin in accordance with the provisions of the Drainage Act, requesting that the following lands and roads may be drained by a drainage works.

Parts of Lots 7 and 8
Concessions 7 and 8
In the Township of Malahide (geographic South Dorchester)

AND WHEREAS the Council for The Corporation of the Township of Malahide has procured a report made by Spriet Associates and the report is attached hereto and forms a part of this By-law;

AND WHEREAS the property owner, D. & J. MacIntyre Farms Inc. (Roll No. 10-040), has constructed and funded the drainage works being incorporated under this report.

AND WHEREAS zero dollars (\$0.00) is the amount to be contributed by the municipality for construction of the drainage works;

AND WHEREAS the Council is of the opinion that the drainage of the area is desirable;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF MALAHIDE UNDER THE DRAINAGE ACT ENACTS AS FOLLOWS:

- 1. The report, dated November 8, 2022, and attached hereto is hereby adopted and the drainage works as therein indicated and set forth is hereby authorized, and shall be completed in accordance therewith.
- 2. (a) The Corporation of the Township of Malahide may borrow on the credit of the Corporation the amount of \$0.00 being the amount necessary for construction of the drainage works.
 - (b) The Corporation may issue debentures for the amount borrowed less the total amount of,

- 1. Grants received under section 85 of the Act;
- 2. Commuted payments made in respect of lands and roads assessed within the municipality;
- 3. Moneys paid under subsection 61(3) of the Act; and
- 4. Moneys assessed in and payable by another municipality, and
- (c) Such debentures shall be made payable within five years from the date of the debenture and shall bear interest at a rate not higher than the rate charged by the Ontario Municipal Improvement Corporation on the date of sale of such debentures.
- 3. A special equal amount rate sufficient to redeem the principal and interest on the debentures shall be levied upon the lands and roads as set forth in the Schedule to be collected in the same manner and at the same time as other taxes are collected in each year for five years after the passing of this By-law.
- 4. All assessments of \$500.00 or less are payable in the first year in which the assessment is imposed.
- 5. This By-law comes into force on the date of the passing thereof and may be cited as "W. McIntyre Drain".

Background:

The 2022 budget program which was presented in March through April 2022 presented the end of a 5-year budget cycle, and accordingly 2023 projections have not yet been presented to Council. As the *Municipal Act, 2001* requires that the Council re-adopt the budget for the coming year and the 2023 budget has not been presented or received any formal adoption at the time of writing this report, and is not expected until as early as March 2023, staff are concerned that various planned capital activities from the upcoming multi-year budget may not be undertaken due to weather and competing priorities. There is also benefit to tendering various works and procuring materials early in the year before suppliers and subtrades are fully booked. Accordingly, staff are seeking direction from Council to proceed with the various Capital Projects noted herein

which have been presented in various other long-term plans outside the formal annual budget process.

It should be noted that the recommended items/projects are not an all-encompassing list of directives or capital works for the Township through 2023, and only those works which have received prior direction for inclusion in 2023 through other long-term plans and require early initiation to ensure appropriate resources are available and projects may be completed.

Comments/Analysis:

Road Needs Study Update

The Asset Management Plan was received and adopted by Council in June, 2022 as part of meeting the requirements of O.Reg. 588/17 for implementing a degradation and funding strategy for the municipality's core infrastructure assets. The following resolution was passed:

WITH WINTER CONTROL EQUIPMENT

Recommendation:

THAT Report No. PW-23-04 entitled "Tender Award – Single Axle Dump Truck Complete with Winter Control Equipment be received;

AND THAT the bid received from Team Truck Centres/Premier Truck Group of London, Ontario be accepted in the amount of \$358,505.00 (plus applicable taxes), for the purchase of one new single axle dump truck complete with winter control equipment.

Background:

The current fleet replacement schedule identifies the replacement of one single axle plow truck in 2023. The unit being replaced is a 2011 International Durastar plow and spreader combination unit that provides winter control services to village streets across the Township.

Township Staff issued a tender on November 16, 2022 for one Single Axle Dump Truck with Winter Control Equipment with an anticipated delivery in the spring of 2024. This was done under the direction of the CAO provided through the delegated authority for Restricted Acts during Lame Duck, and as previously reported to Council in report no. CAO-22-18 (dated December 1, 2022).

The tender was open for four (4) weeks, closing at 11:00am local time on December 16, 2022 with two bids received.

Comments/Analysis:

The Staff have evaluated the bids to verify that they conform to the required vehicle specifications.

Results:

Based on a thorough review, the Staff recommend Council accept the low bid as submitted by Team Truck Centres/ Premier Truck Group of London, Ontario for the supply of one (1) new Freightliner Single Axle Dump Truck complete with Winter Control Equipment with estimated delivery in Spring 2024.

It was noted in the CAO-22-18 2nd Informational Report: CAO Use of Restricted Acts Clause that early pre-budget tendering of the replacement truck was sought in order to attempt avoidance of 2024 model chassis with increased emissions requirements. Unfortunately, at the time of tendering (November 2022), staff were notified that no 2023 chassis were available and accordingly on 2024 chassis would be submitted in bids.

Financial Implications to Budget:

The fleet replacement plan identified an expected 2023 budget inclusion of \$315,000 for the replacement of one single axle truck in 2023 through the Capital Equipment Reserve fund.

Though the recommended bid exceeds the estimated replacement cost by \$43,505.00, a comparison of recent tender results of similar single axle trucks with snow plow equipment determined the bid to be a fair price.

The tendered price exceedance can be attributed to several factors including, but not limited to: market demand, manufacturer surcharges, and new 2024 emissions requirements requiring approx. 20% emission reduction. It should be noted that the price quoted includes all anticipated cost as of the time of the bid submission, however future manufacturer surcharges may or may not be added to the final cost before the unit is delivered.

There are sufficient funds in the equipment reserve to fund the purchase as tendered.
